Care and support

Alzheimer’s Society provides almost 3,000 services across England, Wales and Northern Ireland. Our network of Dementia Advisors, Dementia Cafes and support groups provide vital information and personal support to people living with dementia, their families and their carers. By providing local care and support we are changing the world for people with dementia every day.

Campaigning

Alzheimer’s Society speaks for those whose voices might otherwise be ignored. Through detailed policy analysis, lobbying, influencing and direct action, we drive the government to fully support people with dementia, to make vital improvements to primary care and to dramatically increase funding for research.

Research

Alzheimer’s Society funds research into the cause, cure, care and prevention of dementia. We work with the scientific community in partnership with people affected by dementia and presently invest over £6m a year in dementia research. Our aim is to grow this investment to over £10 million a year by 2017.
